# USMILLS 25 YEAR LIMITED RESIDENTIAL BROADLOOM CARPET WARRANTY

We stand behind the quality of our products and take pride in bringing to market beautiful well-designed carpets.

The following details the Residential Limited Warranty issued by USMILLS LLC for all residential carpets. This warranty applies to purchases of USMills Residential carpet bought after Jan 2022.

### WHO IS COVERED.

The original purchaser is covered who has bought this carpet for their own residential use in an owner-occupied residence. This warranty is non-transferable.

#### WHAT TO KEEP

Make sure to keep the following documents and a copy of this warranty:

- Original sales receipt or invoice
- Receipts or invoices from professional cleaning
- Name and information of the installer
- Type and brand of the under-pad used
- If possible, a piece of uninstalled carpet

### THIS RESIDENTIAL WARRANTY COVERS

This prorated warranty includes reasonable labor if installed by a professional installer

- > 25 Years Quality assurance Carpet will be free of manufacturing defects for 25 years.
- > Limited lifetime stain, fade and pet warranty.
- 20 Year texture retention warranty Will not show significant loss of texture or twist from normal foot traffic
- > 15 Year Abrasion Carpet will not lose more than 15% of the face yarn by weight.
- > 25 Years soil Warranty Surface pile of the carpet will not soil by common household use.

### **CONDITIONS**

- No outdoor use is covered. For indoor use only.
- Warranty is non-transferrable
- A proration schedule applies (see below)
- Carpet installation should follow the Carpet & Rug institute Residential installation Standard CRI-105. An FHA/HUD under-pad is required.
- All installations must be stretched over padding.
- All seams must be sealed with an appropriate seam sealer.
- USMills will not cover any installation labor for defects that were clearly visible during or before
  installation like tears, stains, delaminated backing, etc.
- Carpet must be cleaned and maintained according to the guidelines established by the Carpet and Rug Institute (www.carpet-rug.org).
- Your carpet must be professionally cleaned (hot water extraction) at a minimum every 18 months.

### **EXCLUSIONS**

- Stairs
- Non-residential use
- Stains from paints, Shoe polish, lipstick, iodine, oil-based materials, vomit, motor oil, hair dye, adhesives.
- Carpet treated after installation with any silicone based anti-soil or anti stain treatments
- Crushing or matting marks left by furniture
- Installation defects including burns, cuts, stains, tears, etc.
- Excessive moisture and flooding. Moisture related issues affecting the integrity of the carpet are <u>not</u> covered.
- Incorrectly installed carpet or carpet installed over existing pad
- Carpet that is glued down
- Carpet installed in areas with extensive direct sunlight are not covered for fading.
- The pet warranty includes the physical appearance of a pet stain but excludes the odors.
- Pet stains that are not accidental but appear from regular occurrence are not covered.

#### **IN CASE OF DEFECT**

In case of a defect covered under this warranty.

- If within one (1) year of the purchase reasonable cost for labor and freight will be covered.
- The affected area will be repaired or replaced.
- If a replacement is needed USMills will credit the installing flooring subcontractor a percentage of the replacement cost of new carpet according to the proration schedule below.
- Costs incurred for moving any type of furniture installed over the carpet are <u>not</u> covered.

In case you believe your carpet has a defect covered under this warranty, please contact the retailer where you purchased the carpet, all communications will go through them. In case you are not being serviced please contact <a href="mailto:sales@usmills.com">sales@usmills.com</a>. A claim report must be filed with USMills prior to any replacement or credit. Your USMills dealer must personally inspect this claim.

### 25 Year Proration schedule

If the carpet does not perform according to the warranty USMIIIs will provide a credit for equal to the cost of the carpet material only following the below schedule.:
